Carmona IATF Order #6: to enforce stricter GCQ in the town always their Home Quarantine Passes and valid IDs showing

CARMONA, Cavite -- The local government here thru the local IATF issues Order No. 6 to enforce stricter implementation of the General Community Quarantine (GCQ) in the entire municipality.

Under this ruling, longer curfew hours will be implemented from 6pm-5am effective July 29, 2020 with community checkpoints located in strategic areas in the town that will be manned by the Carmona PNP, barangay personnel, and volunteer groups. Everyone is requested to observe the minimum health protocols inside establishments and in public areas including the total liquor ban which is in effect in the municipality.

On the other hand, violators of the quarantine protocols will be penalized with commensurate fines and/or community service depending on the decision by the court of law.

Authorized Persons Outside of Residences (APOR) are always required to bring their company ID and QR code for employees/workers. Those who are non-workers need to bring always their Home Quarantine Passes and valid IDs showing proof of age and allowed only for essential errands like purchase of food, medicines or for medical check-ups.

Similarly, for selfemployed workers valid ID of self employment from the Public Employment Services Office (PESO) is the required documentation.

As originally mandated, persons belonging to the vulnerable sectors like those aged below 21 years, and those above 59 years old (senior citizens), those with existing health conditions, co-morbidities,

Cavite's Educational Plan bared, strictly for students' learning

TRECE MARTIRES CITY, Cavite--Cavite Governor Jonvic Remulla bared the province's Educational Plan in anticipation of the opening of classes on August 24, 2020 following the Department of Education's blended learning modalities.

According to Gov. Jonvic Remulla, the provincial government would invest over Php4M a year for 5 years to set up a Virtual Private Network to serve the entire DepEd (approximately 650,000 students) in Cavite to run the Cavite Educational program.

This will involve setting up 5,000 access points across 829 barangays to reach 400,000 homes for the whole province.

Similarly, the program will use the DepEd system of transmission of lessons that can be downloaded with the use of electronic gadgets (smart phones, laptops, desktops, and tablets).

Moreover, the system is time bound sensitive for assessment purposes to monitor the progress of the children.

On the other hand, the program's limitations are the access to devices with those who could not afford a gadget will have to rely on the materials printed by DepEd and the system cannot be used for any other application except for *continue to page 3*

DA-4A distributes interventions

TRECE MARTIRES CITY --The Department of Agriculture IV-A in coordination with the provincial government here thru the Provincial Veterinary Offce recently distributed chicks and veterinary medicines to African Swine Fever (ASF) affected farmers.

DA-IVA Regional Livestock Program Coordinator Ms. Vilma Dimaculangan led the turn-over activity held at the DA Cavite Research and Experiment Station (DA-CARES) in the municipality of Naic.

About 237 farmer beneficiaries from the municipalities of Indang, General Mariano Alvarez, Carmona, Ternate, Magallanes, Maragondon, and Noveleta received chicks, feeds, housing, vitamins and medicines as the DA's interventions for the livestock raisers to be able to get back on their feet and restart their livelihood.

The recovery and rehabilitation plans were laid out to enable the ASF affected farmers to recover and rise up through a different form of livelihood that will serve as their new source of income.

A similar activity was conducted July 23, 2020 with farmer beneficiaries from the municipalities of Silang, General Emilio Aguinaldo, Amadeo, Naic, Tanza, Alfonso and Mendez. (Ruel Francisco, PIA-Cavite/with reports from PICAD)

Trade chief urges public to support local producers, service providers

PASIG CITY-- Trade and Industry Secretary Ramon Lopez reiterates his call to support local producers and micro, small, medium enterprises (MSMEs) recover who were affected by the COVID-19 pandemic.

During the Laging Handa Public Briefing on Friday, Lopez assured that the Department is all out in providing support to local producers.

Lopez added that the DTI provides assistance to local producers especially in the online industry and through holding of webinars.

QC sets guidelines to speed up contact tracing in workplaces with massive manpower

CALOOCAN CITY -- The Quezon City government has issued guidelines to enhance contact tracing and enforcement of health protocols in companies with 100 or more employees.

Mayor Joy Belmonte said the guidelines will help speed up contact tracing in case of positive COVID-19 cases in such workplaces.

Under the guidelines, Belmonte has tasked workplaces with 100 or more employees to conduct meticulous contact tracing when there is a confirmed COVID-19 case among their employees or close contacts of their employees.

A person is considered a close contact if he or she had a face-to-face contact with a confirmed COVID-19 case within one meter distance, for more than 15 minutes and within a 14 day period from the confirmed case's onset of symptoms.

symptoms were exhibited. The management should undertake the swab testing of the close contact if the person exhibits any COVID-19 symptoms such as fever, difficulty breathing or body aches.

"In either case, close contacts should not be allowed to report for work immediately upon identification as such, and should be required to self-isolate at home," Belmonte said.

The close contact may end quarantine when the person ends the 14-day quarantine without symptoms, as confirmed by a medical doctor, or a certification showing a negative swab test.

Companies are also mandated to provide the City Epidemiological Surveillance (CESU), Unit through qcsurveillance@quezoncity. gov.ph, with updates regarding confirmed cases and close contacts among the workforce.

If economically feasible, companies are encouraged to provide daily allowance to employees on home quarantine.

To help speed up contact tracing, the local government mandates big companies to require each employee to list down all usual close contacts, both inside and outside work, even prior to any confirmed or suspect COVID-19 case.

"Employees are also required to undergo selfmonitoring for symptoms daily. Employees that experience any onset of symptoms during work should inform their supervisor and leave the workplace immediately," said Belmonte.

In addition, the city government enjoins companies to strictly implement the usual preventive measures, such as improved workplace ventilation, practice work from home if possible, use of face masks, physical distancing and frequent sanitation and disinfection of workplace.

Companies that violate the guidelines face suspension or revocation of business permit, aside from other applicable penalties under relevant laws, ordinances or regulations. (QC PAISD/PIA-NCR)

PNP to streamline operations of all frontline service offices • Supervisory Office for Security

CALOOCAN CITY--The Philippine National Police is implementing new measures that will streamline operations of regulatory units and offices that provide frontline administrative services to cope with the heavy demand of securing police requirements at the National

Chief, PNP Police General Archie Gamboa directed the PNP Headquarters Support Service (PNP-HSS) to strictly observe the rules and regulations under streamline operations to protect the camp from further human to human transmission and resurgence of COVID-19 cases beginning Monday, August 3, 2020.

"We see that there's a need to adopt more measures and

protocols designed to extensively reduce if not eliminate person to person transactions inside Camp Crame, particularly among the many PNP frontliner services to contain the threat of COVID-19 resurgence inside Camp Crame," Gamboa said.

Under the new system, the PNP-HSS led by its director, PBGen Alexander Sampaga released an advisory that "All frontline servicing units/ offices shall follow the reduced maximum number of clients policy and a color-coded queue card which will be used to maintain the allocated maximum transaction per day to 950 clients: · One Stop Shop for Security Guards License (LSP/SG) OSS - 250

and Investigation Agencies (SOSIA) - 150

• Permit to Carry Firearms Outside of Residence (PTCFOR) - 50

CALOOCAN CITY- Manila Mayor Francisco 'Isko Moreno' Domagoso has signed an ordinance realigning P40 million of the city's budget to purchase more medical equipment and supplies to strengthen Manila City's COVID-19 mass testing efforts.

Domagoso signed Ordinance No. 8657 which authorizes a budgetary realignment to cover COVID-19 related expenses of the Manila City government.

"Gagamitin natin itong P40 million para palakasin ang health sector, and to commit ourselves for mass testing in Manila," Domagoso said in a statement.

"This is part of our continuous efforts in sustaining and

strengthening our health servcces in our own little way for the peace of mind of our people. This effort is make COVID-19 testing accessible, efficient and free for all," the mayor said.

The Manila City Council approved the supplemental budget which will be sourced from the City Development Fund.

About P20 million will be allocated for the procurement of COVID-19 testing reagents, P10 million for the maintenance and operating expenses of COVID-19 testing laboratories, and P10 million for the purchase of medical equipment.

According to the mayor, the City government has been consistently strengthening its efforts to make COVID-19 tests free for all, both Manilans and non-Manilans.

The city government has established drive thru testing sites and walk-in testing sites that cater to Manilans and non-Manilans as well.

To process COVID-19 tests, Domagoso said the city government is using serology testing machines from American healthcare firm Abbott which have accuracy of 99.6% for specificity and 100% for sensitivity.

Currently, the Manila City government has four COVID-19 serology testing machines which are able to process more than 89,000 tests a month.

The mayor added that another serology testing machine will be procured by the city government. This will increase the city government's serology testing capability to about 112,000 tests a month. (PIO Manila/PIA-NCR)

EDITORYAL What's worse than this

The pandemic has made us rely on online transactions, including food which, due to the call of the times, are wrapped in disposable plastic.

The year was unkind to the Philippines from the start.

While neighboring China was starting to grapple with a still unnamed and very hostile virus, our minds were focused on fighting a natural disaster.

Taal volcano was mean.

On 12 January 2020, a phreatomagmatic eruption from its main crater spewed ashes across CALABARZON, Metro Manila and some parts of Central Luzon and Ilocos Region.

School classes were suspended. Work schedules were disrupted. Flights were affected.

What was otherwise a scenic scene at the vicinity of the volcano turned into what seemed like a barren desert. Other parts were like ghost towns. Plants and trees and their fruits decayed in wraps of sulfur and cement.

Tent cities rose. Food and water were scarce.

Hopes were dashed. Dreams were lost.

The country is prone to natural disasters alright.

Yes, we know that.

Typhoons came and went, and killed not a few. They brought floods, landslides, volcanic eruptions, earthquakes and tsunamis.

What catastrophe has not come into the Pacific Ring of Fire where we sit at this moment? It is a geologically unstable region, shared by the Pacific and Eurasian tectonic plates. Down below is where Hades is. There is no contest between us and the world's natural movements. But we are contributing to its degradation. We are hastening our demise. High annual population growth rate is a major factor in the major human-caused environmental degradation.

Uncontrolled population leads to loss of agricultural lands, deforestation, soil erosion and air and water pollution.

AS a Filipino activist committed to radical social change, I like JacobinMag.com, the magazine that introduces itself as one "of culture and polemic." Well, despite the lapse in judgment that spurred this missive (which we'll get to shortly), I still do. I like the fact that its articles are short, directto-the-point, and relatively free of jargon. Its articles on the struggle of the workers and people of Greece against austerity, for example, are enlightening.

Jacobin's publication of "The War Is Over" by one Alex de Jong, however, is a low point for the website. Despite its attempt to feign even-handedness, de Jong's article clearly demonizes the underground Communist Party of the Philippines (CPP) and the open national-democratic umbrella organization Bagong Alyansang Makabayan (Bayan, which means "nation" in Filipino) before an international audience.

While admitting that the The government's resources and savings have been depleted by the CPP and Bayan constitute "the strongest current on the Philippine Left," the article downplays the vast difference in strength between these Reaffirmist groups on the one hand and so-called Rejectionist groups on the other. In fact, it tries to project parity of strength between the two camps. It also accuses the CPP and Bayan of "intellectual stagnancy" and "violence," implying that other groups of the Philippine Left are intellectually vibrant and, well, peaceful. De Jong defines the thrust of his article as that of tracking down the reasons why the CPP and Bayan remain the strongest formations on the Philippine Left. This way, he can zero in on the two groups' negative points, broadly conceived, while ignoring the more glaring faults and weaknesses of

And yet de Jong has the gall to try to paint the flawed picture where Reaffirmists "are equal in number to all the [Rejectionist] groups put together."



Gatchalian: Govt's policies, infrastructure must be ready for e-vehicles investments to grow globally

By Jerome Carlo R. Paunan CALOOCAN CITY-- Senator Win Gatchalian on Sunday said government needs to be ready with its policies and infrastructure before the e-vehicle becomes more affordable and popular in the country.

For this reason, Gatchalian, who chairs the Senate Committee on Energy, is pushing for the creation of a sound policy and regulatory framework for the adoption of electric vehicles (EVs) and the sustainability of the e-vehicle investments to grow globally competitive.

While the COVID-19 crisis shows that effective public transport is vital to keeping cities running and quarantine measures have put a strain on the country's public transport system, Gatchalian said over the long term, public transport is one investment that can create jobs quickly while reducing carbon emissions and innovating people's access to their workplaces.

The bill is now up for interpellation in the Senate and once the bill becomes a law and if implemented correctly, the senator expresses confidence that the country's dependence on oil will be greatly reduced and that the country will save P297.92 billion of annual oil importation. The bill provides fiscal and non-fiscal incentives for the importation, utilization, and manufacture of EVs. This includes a 9-year exemption from value-added tax, customs duties, and discounts on the Motor Vehicle User's Charge as well as expedited registration procedures for EV users.


