issue isn't just that plastic bags take forever to disintegrate, it is the massive number of plastics Filipinos use and quickly throw away. These plastics are choking the life out of our oceans and forests and polluting our communities," Legarda said.

Legarda, a three-term Senator and representative of the Lone District of Antique, said that the complete eradication of single-use plastics, a term commonly referring to disposable plastic items that are thrown after one-time use, must be supported as an environmentally-conscious solution to the plastic crisis.

As the principal author of Republic Act No. 9003 or the Ecological Solid Waste Management Law of 2000, Legarda suggested that instead of "disposable" plastics, ready alternatives can be in the form of reusable ecobags, bamboo or wood utensils, or glassbased containers in homes. She added that companies must change their economic mindset, wasteful production processes and packaging methods, from the use of seemingly cost-effective plastics into investing in reusable and recyclable products which are more sustainable in the long run.

The Climate Change Commission (CCC), led by Chairperson-designate its Department of Finance Secretary Carlos G. Dominguez, supports the nationwide ban on singleuse plastics as a vital component of a low-carbon economy and to advance sustainability, promote biodiversity, ensure food security, and curb pollution.

The climate body stressed that the passage of a legislative measure on this subject matter will further push policymakers to proactively review the implementation of existing environmental laws, such as the Clean Air Act (Republic Act or RA No. 8749), Ecological Solid Waste Management Act (RA 9003), Clean Water Act (RA 9275), and the Climate Change Act (9729) to ensure a more holistic, sustainable, and inclusive recovery of our communities and the environment. In 2020, the BIR shut down the operations of two Philippine Offshore Gaming Operators (POGOs) and collected P7.18 billion in taxes, which was 11.71 percent more than the P6.42 billion collected by the BIR in 2019 from these businesses.

One Act). hired 897 new employees and promoted 1,170, which brought the personnel strength of the bureau from 9,549 workers in 2016 to 12,449 in 2020. For 2021, Dulay reported to Dominguez that the BIR aims to increase its collection by 7.23 percent to P2.08 trillion by improving tax compliance among all taxpayers, strengthening its budget management system, speeding up its recruitment and promotion of employees, expanding its computerization efforts, and further intensifying its enforcement activities such as Oplan Kandado, RATE, and tax audits.

The second phase of the BIR's Asset Information Management Program (AIMP) was also implemented in 2020, he said.

This project provides a system that includes an integrated data warehouse and analytics that would integrate information from various agencies with existing Tax Amnesty Returns and Statement of Assets, Liabilities and Networth (SALNs) filed under Republic Act (RA) No. 9480.

Dulay said the BIR rolled out in last year's fourth quarter its ePERA (Personal Equity and Retirement Account)

meanwhile, seized 55 units of cigarette-making machines. 4.89 million packs of assorted cigarette products, and 22.39 million counterfeit tax stamps valued at P1.23 billion in 2020, Dulay said.

Dulay said the BIR also secured ISO certifications for six BIR regional offices and 35 revenue district offices last year, and issued three revenue memorandum circulars (RMCs) to related to improving the ease of doing business.

the Among key accomplishments of the BIR in 2020 was its participation in the Small Business Wage Subsidy Program (SBWS), which proceeded smoothly and delivered financial assistance to over 3 million workers of small businesses promptly owing to the use of computerized processes.

Dulay said the BIR plans to roll out its Enhanced Internal Revenue Stamp Integrated System (IRSIS) in the first quarter of this year to further step up its campaign against cigarette

smuggling.

The nationwide rollout of the Internal Revenue Integrated System (IRIS), which will serve as the BIR's central tool and repository to process taxpayers' information, is expected in the fourth quarter of 2021, along with the pilot implementation of its Electronic Invoicing System, he said.

The Online Registration & Update System (ORUS), which is a web-based system that will provide an end-to-end process for registration and updating of taxpayer registration information, is due for implementation in the fourth quarter, he said.

By the first quarter of this year, Dulay said the BIR expects Collection Performance its Dashboard to be up and running.

This will enable the central office to check the

collection performance of each collecting office/Revenue Region of the BIR against the assigned goal, compare it with the previous year and classify it by type of collection, he said.

The BIR will also allow taxpayers to book online appointments with revenue officers regarding tax-related concerns starting this year, Dulay said.

He said the bureau is targeting to complete its in-house developed One-Time Transaction (ONETT) tracking system this year to allow it to monitor the ONETT transactions from the date the taxpayer secured the services of the revenue officers for the computation of the tax due up to the time of securing the Electronic Certificates Authorizing Registration (eCARs). LGU Ternate imposes P20 **Ecological Fee to Kaybiang** tunnel visitors

TRECE MARTIRES CITY, Cavite -- The local government of Ternate imposed a P20 Ecological Fee for tourists, motorists, and motorcycle riders who visit the town particularly the Kaybiang tunnel.

Collection of said fee last weekend, February 6 & 7 earned flak and criticisms from the motoring public and local tourists because of the unexpected and unannounced action from the local authorities.

Ternate Mayor Lamberto Bambao through his staff Bryan Novejas explained the collection of said fee is in accordance with Municipal Ordinance No. 5 s. 2014 authored by then Councilor Lorenz Khalil Soberano, Chair fo the Committee on Trade, Tourism, Culture, and Arts during the term of Former Mayor Herminio Lindo.

Also known as the "Ternate Tourism Ecological Fee Ordinance," it was passed to ensure the benefit and enjoyment of the people of the locality, judicious and wise utilization, protection and conservation and management on a sustainable basis of its natural resources with the necessity of maintaining sound ecological balance.

Novejas explained that "to generate funds as a source of revenue to finance the implementation of environmental and tourism plans and projects and to provide the necessary amenities and services out of the collected fee that goes to

peace and order, beautification, livelihood, health assistance."

"This is the way we can meet the needs of the local government to provide for the cleaning of garbage left by riders and tourists on the road or in Kaybiang Tunnel and to be used for the mobility of police for peace and order, rescue by MDRRMO in times of accidents within the vicinity. Saan naman kame kukuha ng funding, we are only a 4th class municipality," added Novejas.

Kaybiang tunnel is a 300 meter long tunnel with 4.85 meter wide vertical clearance completed on July 1, 2013. The tunnel is considered the longest tunnel in the country which serves as an alternate route going to the municipality of Nasugbu. It has been frequented by local tourists, and motorcycle riders even cycling enthusiasts for souvenir photos and access to the beautiful beaches in Ternate and Nasugbu.

Meanwhile, Municipal Treasurer Brendalyn Olano pointed out the ecological fee will be collected on weekends and residents of Nasugbu are exempted upon presentation of proof of residency.

The city government is also working with a private company located in Barangay Longos who will provide the cold facility needed for storing the vaccines the city government procured from drug manufacturers, Pfizer, Astrazenica and Moderna.

Three Ultra High Temperature Freezers in the Southern Tagalog Regional Hospital will also be utilized for storing vaccines to prevent them from spoiling upon reaching city borders.

To recall, Mayor Lani Mercado-Revilla has signed an Executive Order for the establishment of technical working groups who will oversee

the vaccination operations center, database and registry, communication and information dissemination, procurement and finance, and logistics.

government Local offices, such as the City Health Office, MIS, Public Information Office, City Budget Office, and General Services Office, have been tapped to handle the logistics entailed in the vaccination program.

Simulations in the citywide vaccination plan were done in different venues, such as Bacoor Elementary School (ALIMA), Southern Tagalog Regional Hospital, and Bacoor Coliseum to determine which area will be most conducive--in terms of travel control, logistics and manpower--in facilitating the successful vaccination rollout. EDITORYAL Deal cards squarely

RODY'S successful efforts to win China's trust merely undid the mistakes of Noynoy and Obama that nearly resulted to a point of no return in the maritime conflict.

Under his watch, President Rodrigo Duterte proved:

• It is possible to engage China in deep friendship while tackling the maritime rift.

• The West Philippine Sea posturing is the result of the struggle between two economic powers, which the country can disengage.

• The United States needs the country more than otherwise, which is the reason for the need to overhaul the various military agreements that are tilted heavily toward American interest.

To give United States President Joe Biden leeway in crafting his policy in the region, Mr. Duterte extended a decision to terminate the Visiting Forces Agreement (VFA), the pact signed in 1998 that contained the ground rules on the temporary presence of American troops in the country.

A collateral deal signed during the term of former President Noynoy Aquino called the Enhance Defense Cooperation Agreement (EDCA) allowed the Americans to use Filipino military bases to host soldiers and military equipment.

As a result of the continued interference of American legislators who are caught up in image-boosting ploys prior to the elections last November, Mr. Duterte threatened to scrap the agreement.

Through the instigation of some American senators allied with detained Senator Leila de Lima, their government canceled the visa of Senator Ronald "Bato" de la Rosa allegedly over the war on drugs deaths.

If there will be a review of the military agreements, EDCA should be the first to be placed under the lens, since it was the product of another Democrat who was willingly bootlicked by Aquino.

During a visit of former US President Barack Obama in April 2014, Aquino presented a signed executive deal, which is the EDCA, that allows American forces to have a rotating presence in the country.

Obama then had launched an Asian pivot policy that was meant to contain China, and EDCA was a key component of the program since the Americans will have a guaranteed station for their military forces in the region.

Aquino then had shut out China as he refused to hold any discussion with Chinese officials and instead, on US directives, filed a case with the Permanent Court of Arbitration (PCA) on the disputed maritime regions.

The PCA issued an award that declared invalid the nine-dash line claim, but it was unenforceable since China, insisting on discourse only among nations involved, did not recognize the proceeding.

Noynoy made clear in delivering EDCA that he was with the American pivot policy all the way and even instigated the West Philippine Sea (WPS) standoff to get Obama's back pat.

He sent a Philippine Navy Hamilton-class cutter that was then recently acquired

The pivot did not contain the rise of China. Instead, China became more aggressive, pressing its claims in the region and the Senkakus where it also has a territorial rift with Japan.

Who should or should not take **COVID-19 vaccines?**

By Mary Rose delos Santos

IN the 39th installment of the University of the Philippines' webinar series on 5 February 2021 titled, "Stop COVID Deaths: Virtual Grand Rounds," Drs. Regina Berba and Inay Dans from the UP-Philippine General Hospital and Dr. Shelley Ann Dela Vega of the National Institutes of Health from UP-Manila highly recommended getting COVID-19 vaccination as the only way to develop herd immunity.

However, they advised people with specific health conditions to consult their health professionals before inoculation. These

people are:

People 1. will who experience immediate allergic reactions to first dose of COVID-19 vaccine or any of its components such as polyethylene glycols (PEG) and polysorbates. If a patient had rashes or severe anaphylactic reaction after injecting the first dose of COVID-19, experts advised not to get the second dose.

2. People who had allergic reactions to other types of vaccines or injected consult therapy should their immunologists for evaluation.

3. Immune-compromised individuals with the following conditions:

a. severe allergy to a vaccine component;

b. history of severe allergy to any vaccine or injectable medication;


4. People who currently have COVID-19 should wait until they have recovered. If a person had antibody therapy as part of treatment, he/she should wait for three (3) months before getting vaccinated; and

5. Children below 16 years old, as their case are still being studied.

Meanwhile, experts from UP-PGH recommend vaccination to individuals immunodeficiency with autoimmune diseases and consult but advised to their healthcare provider to determine personal risks and benefits and whether to receive the vaccine or not.

People who were infected with COVID-19 in the past may still benefit from getting the vaccine. Older

people without allergies to vaccines should get vaccinated since many of them have chronic degenerative diseases that predispose them to COVID-19 complications and death.

QUEZON CITY-- A waste 380 million tons of plastic and pollution watchdog group has offered a timely advice on Valentine's Day to lovers of single-use plastics (SUPs): break up or perish.

The EcoWaste Coalition called on Filipinos from all walks of life to break up with SUPs as this toxic relationship with throw-away plastics the ecosystems, especially the marine environment.

"We can

produced per year are for single-use, or used for a few minutes and then thrown away like the ubiquitous plastic bags, drinking bottles, cups, sachets, wrappers, cutlery, straws, stirrers, etc.

Every year, some eight to 10 million tons of plastic and their chemical additives are dumped into is threatening the health of the oceans and the results deeply concerning: are million aquatic one live animals are killed due without SUPs, but we to plastic pollution, 100 policy measures that will reduce and control plastic production, and promote plastic-free alternatives that can be reused, recycled or composted.

Locally, the EcoWaste Coalition, Oceana Philippines and environmental other health groups have been pushing the National Solid Waste Management Commission to identify and consequently prohibit nonenvironmentally acceptable products and packaging (NEAP) with SUPs on top of the list. R.A. 9003, or the Ecological Solid Waste Management Act, requires the commission to issue the NEAP list one year after the law took effect, which was two decades ago in 2001.

To bid adieu to our convenient but toxic relationship with SUPs, the EcoWaste Coalition has advised consumers to start a loving and enduring relationships with ecological alternatives to SUPs, including:

1. Bayong, fabric bags and other reusable bags instead of plastic carry or grocery bags.

2. Tiffin carriers, stainless


steel lunch boxes and repurposed bottle jars instead of polystyrene food containers.

Water canteens, jugs 3. or flasks, with no lead coatings, in place of plastic water bottles.

Washable glasses, 4. tumblers or mason jars in lieu of plastic cups.

5. Glass, porcelain and other lead-free dishware instead of disposable plates.

6. Reusable bamboo and metal straws or, better still, go straw-free and drink straight from the glass or bottle. (Ecowaste Coalition)

ASEANoxensymbolizing fragility strength, in biodiversity -ACB chief

CALOOCAN CITY-- The chief of the ASEAN Centre for Biodiversity (ACB) has highlighted the crucial role of the wild large-horned mammals belonging to the family of bovine species across the ASEAN region in line with the Lunar New Year observance today celebrating the Year of the Ox.

"Today, we also take the opportunity to highlight the crucial role of the wild large-horned mammals belonging to the family of bovine species across the ASEAN region. While their contribution to the people's nutrition and livelihood are invaluable, the presence of these herbivores contributes to the health and productivity of ecosystems,"said ACB Executive Director Dr. Theresa Mundita S. Lim.

"Apart from adding balance to the food chain as prey for predators, wild ox or wild cattle species help disperse seeds and cycle nutrients in the soil," Lim added.

To recall, the Lunar New Year is widely celebrated in the ASEAN region, particularly in member states where the event is declared a national holiday.

"With optimism and renewed hope for healing and recovery, the ASEAN Centre for Biodiversity joins the ASEAN Member States (AMS) in celebrating the start of the Lunar Year of the Ox," Lim said.

"At this time, we couldn't help but think of the forest-dwelling kouprey, or grey ox (Bos sauveli) of Cambodia, which is a critically endangered and possibly extinct species. This species remains a mystery as no sightings have been reported since the 1980s. Other bovine species in the ASEAN need not suffer the same fate as the kouprey," she added.

"Wild ox species can still be saved from extinction by implementing species conservation programmes and conservation and protection of the species' natural habitats. Among these notable endangered species are saola (Pseudoryx nghetinhensis) of Viet Nam and Lao PDR; dwarf buffalo species, anoa (Bubalus depressicornis and B. quarlesi), of the Sulawesi and Buton islands of Indonesia; tamaraw (Bubalus mindorensis), another dwarf buffalo species endemic to the island of Mindoro, Philippines; and banteng (Bos javanicus), which is found across Cambodia, Indonesia, Malaysia (Sabah), Myanmar, Thailand, and Viet Nam. The largest cattle species in the world, the gaur (Bos gaurus) is also found in South and Southeast Asia. However, its population has declined in recent years," the conservation expert enumerated.

Lim said, however, some of the ASEAN Heritage Parks are also home to wild cattles.

"For instance, Mounts Iglit-Baco National Park in the Philippines serves as a refuge for the iconic tamaraws. Gaurs can be seen in Taman Negara National Park in Malaysia and Kaeng Krachan Forest Complex in Thailand. Vu Quang National Park in Vietnam is home to saolas. Kaeng Krachan Forest Complex, on the other hand, hosts a population of banteng," she said.





BIR reports 2020 accomplishments, 2021 goals

MANILA-- Internal Revenue Commissioner Caesar Dulay has reported that the Bureau of Internal Revenue (BIR) was able to surpass its collection goal in 2020 through the strict monitoring of tax compliance, topped by making good use of the bureau's Taxpayer Account Management Program (TAMP).

The BIR's strict monitoring of tax compliance withholding included also remittances of national the government agencies, local government units (LGUs), top withholding taxpayers and other private withholding agents, and employing online facilities, said Dulay in his accomplishment report to Finance Secretary Carlos Dominguez III. Citing BIR preliminary data, Dulay said the bureau collected a total of P1.94 trillion in 2020, or 15.14 percent over the revised goal of P1.68 trillion set by the Development Budget Coordination Committee (DBCC) for last year. Dulay informed Dominguez that the BIR also intensified its collection of delinquent accounts in 2020, with a total of 207 warrants for garnishment, and distraint and levy issued, which led to the collection of P690 million in taxes.

settlements in 2020 resulted to another P308.96 million in taxes paid to the BIR.

Last year, the BIR was able to heighten its audit and enforcement activities despite the pandemic through the organized issuance of electronic Letters of Authority (LOAs), the prompt issuance of subpoenas, preliminary assessment notices and final assessment notices to delinquent taxpayers, Dulay said. The BIR also launched an information campaign on its tax amnesty for delinquent accounts and estate taxes, and its Voluntary Assessment and Payment Program (VAPP), he said. Dulay said the bureau collected P5.63 billion in 2020 from delinquent filers and estate taxes, or 97 percent more than the P2.86 billion collected from errant taxpayers in 2019. Its Run After Tax Evaders (RATE) program led to the filing of 157 cases before the Department of Justice (DOJ) with aggregate tax liabilities of P7.45 billion, and another 24 cases filed with the Court of Tax Appeals (CTA) with total estimated liabilities of P753.75 million, Dulay said. Under the Oplan Kandado program, 209 establishments were padlocked for tax law violations, which

Congress moves closer to ban single-use plastics; address waste, flooding

QUEZON CITY -- Sixty one bills in the House of Representatives seeking to phase-out or regulate single-use plastics were tackled recently in a technical working group chaired by Rep. Francisco "Kiko" Benitez under the House of Representatives Committee on Ecology..

"This legislation is a critical, concrete step towards a circular economy. There are products that we can immediately ban. But for products that are not easily replaceable, we must give manufacturers time to produce alternatives and diversify," Benitez said.

The lawmaker emphasized the need to consult all stakeholders from the sectors that will be affected, in view of the wide range of products to be covered by the bills such as plastic straws for drinks, plastic coffee stirrers, plastic bags of thickness below 50 microns, plastic cups and cutlery, containers of polystyrene, balloons and candy sticks, buntings, and confetti. Deputy Speaker Loren Legarda, for her part as co-author, also expressed strong support for the immediate passage of the legislative measure regulating and prohibiting single-use plastics.

"We have seen with our own eyes and we have known for some time that single-use plastics have a negative impact on the environment. This is even more problematic in our floodprone areas, where plastic wastes clog our sewerage systems. The *continue to page 2*
