KAWIT, Cavite — The National Historical Commission of the Philippines (NHCP) on Saturday held a ceremonial "March of Flags" at the NHCP Museum of Emilio Aguinaldo in the historic town of Kawit to start the 100-day countdown to the 125th Anniversary of Philippine Independence and Nationhood.

The parade, carrying the theme "Freedom, Future, History," features national flags and the Philippine flag that will be used at the Independence Flagpole in Liwasang Rizal Luneta, Manila, on June 12, 2023.

NHCP Chairman Dr. Emmanuel Franco Calairo said that the event "is very important because this is a public awareness campaign for Filipinos to remember, enjoy, and learn a lesson about the nation's history for the future of our country."

## PBBM signs law converting Carmona into component city

MANILA – President Ferdinand R. Marcos Jr. has signed a law converting the municipality of Carmona in Cavite province into a component city.

Under Republic Act (RA) 11938 inked by Marcos on Feb. 23, the converted town will now be known as the "City of Carmona" which will remain under the jurisdiction of Cavite province.

"The territorial jurisdiction of the City shall be within the present metes and bounds of the Municipality of Carmona," the law read.

The City of Carmona will continue to be a part of Cavite's Fifth Legislative District, a unit otherwise provided by the law.

RA 11938 mandates the holding of a plebiscite in the municipality of Carmona 60 days after the issuance of the law for the ratification of its conversion as a component city.

"The City of Carmona shall acquire corporate existence upon the ratification of its creation by a majority of the votes cast by qualified voters in a plebiscite to be conducted in the present Municipality of Carmona within 60 days from the approval of this Act," the law read.

"The Commission on Elections shall conduct and supervise each plebiscite. The expenses for such plebiscite shall be borne by the *continue to page 3*

The bronze eight feet tall sculpture was created by Architect Flordeliza Villasenor. In his speech, Remulla reminisced the heroics of Fr. Gomez, the pride of Bacoor, Cavite; Fr. Burgos a native of Manila; and Fr. Zamora from Marikina, who were all sentenced to death and died by garrote on February 17, 1872, in Bagumbayan (now Luneta

Filipino today, the secretary said.

"There will be no Noli Me Tangere, there will be no El Filibusterismo and there will be no Dr. Jose Rizal in Bagumbayan if there was no GOMBURZA in our history, and although their story was short-lived, the effect was longlasting," Remulla said.

"We became a nation because of every man and woman who dedicated their lives for our freedom and democracy," he added.

Remulla is joined by Cavite City Mayor Denver Reyes Chua and City Councilor Nash Aguas during the unveiling of the sculpture which is to mark the 151st death anniversary of the three priests and also to mark National Arts Month. (PNA)

He also urged the academe intensify its monitoring to and regular communication with the students belonging to fraternity groups existing in their institutions.

"Our call to all school officials to monitor and watch over students as well. The same call applies to the families of the students to also watch the activities because we will know that usually, our children will announce that they are going somewhere, stay overnight where only to find out that the destination is initiation rites. If our children asked permission to go somewhere, it would better for them to be accompanied by other members of the family if possible," Maranan explained.

The PNP has recorded a total of 178 incidents of hazing since 2012.

He showed the injuries he sustained from the hazing, particularly at the back of his thighs where he received more than 70 blows using a paddle.

"Ang sabi sa akin is since we have anti-hazing law ang ibibigay na lang 12 to 24 (na palo) marami na 'yung 24 so naniwala ako, plus the benefits na pwede mong matanggap so pinursue ko kasi may financial struggle din kami (I was told that since we have an anti-hazing law, only 12 to 24 (which is beaten) will be given, 24 is already a lot, so I believed, plus the benefits that you can receive, so I pursued because we also have a financial struggle)," Dela Cruz said in a TV interview.

"Pinatakan (din) nila ako ng candle sa likod inukit nila 'yung logo ng fraternity sa likod ko then tinanggal nila 'yung mga patak ng candle sa likod ko gamit ang belt pinalo nila ako (They (also) put a candle on my back, they carved the logo of the fraternity on my back, then they removed the candle drops on my back with a belt and beat me)," he added.

Dela Cruz said he heard Salilig answering in the affirmative after being asked by those conducting their initiation rights if he was okay.

Dela Cruz and the other witness also pointed to the house where the initiation rights happened.

immediately placed under arrest for violation of the Anti-Hazing Law.

Jopia said they were still looking for seven individuals who were already identified and considered as persons of interest. Jopia said they now

consider the incident as a "solved case but not closed yet".

The Biñan police is set to file charges for the violation of Anti-Hazing Law against the suspects before the Department of Justice (DOJ) on Thursday.

Police also recovered on Wednesday the vehicle where Salilig reportedly died while on their way back to Manila.

The vehicle was positively identified by Dela Cruz and the other witness, a member of the fraternity who earlier pointed to the area where Salilig's body was buried.

The owner of the vehicle, Gregorio Cruz, the father of Aaron, a member of the fraternity Biñan chapter who was among the persons of interest on the case, has already been arrested over obstruction of justice.

They may face charges for the violation of Republic Act 11053 or the Anti-Hazing Law and may be penalized of lifetime imprisonment.

Salilig's body was recovered on Tuesday in Imus, Cavite. He was last seen alive on Feb. 17 while on his way to Biñan, Laguna on board a bus.

## Still a Remulla for Cavite's 7th **District** or 149,581 counted votes out of

TRECE MARTIRES CITY, Cavite - The 7th District of this province comprising Indang, Amadeo, Tanza, and this city has a new representative in Congress after Crispin Diego "Ping" Remulla emerged as the winner in the special election held on Saturday.

Remulla was proclaimed Sunday morning by Commission on Elections (Comelec) officials at the Sangguniang Panglunsod Plenary Hall inside the Cavite Provincial Capitol.

He replaced his father, Jesus Crispin "Boying" Remulla, who was appointed Justice Secretary by President Ferdinand R. Marcos Jr. shortly after the May polls last year, resulting in the vacancy.

The younger Remulla, who was the 7th district provincial board member before his poll victory, garnered 98,474 votes, beating former Trece Martires City mayor Melencio De Sagun (46,530), Lito Aguinaldo (1,610) and Mike Santos (1,068).

The total turnout of votes represented 42.11 percent

355,184 registered voters. On election day,

Remulla was accompanied by his wife, Georgia, and father in casting their votes at Tambo Malake Elementary School in Indang.

In an interview, he said they accomplished much during the campaign for he got to know many of his "kababayan" (townmates) in the district.

However, he refused to comment when asked by the media about the disqualification case filed against him by De Sagun, saying he had yet to receive a copy of the complaint.

The disqualification case filed on Feb. 23 stemmed from the Trece Martires local government unit's social media post where he joined a social services event during the campaign period, which, De Sagun claimed, was a clear violation of the election code.

"It is very premature to conclude at this early stage, but we promise to take a deeper investigation for the filed disqualification case," said Comelec chair George Garcia, a native of Indang. (With report from Ferdinand Patinio/PNA)

## **Random manual audit shows Cavite special** polls 99.96% accurate

MANILA - The vote counting machines (VCMs) used in the just concluded special elections in the 7th District of Cavite were found to be 99.96 percent accurate in tallying the votes, the Commission on Elections (Comelec) reported on Tuesday.

The poll body said the random manual audit (RMA) held on Sunday in seven clustered precincts was found to be almost 100 percent correct.

However, it added that one variance was detected between the counts made by the Automated Election System (AES) and the audit.

out of seven clustered precincts randomly selected, it yielded an accuracy rate of 99.95968 percent with only one variance or difference between the counts made by the AES and the RMA," the Comelec said.

This was recorded in the town of Tanza after only 1,066 out of the 1,067 votes matched.

"Said variance can be readily explained by the difference between the visual and mechanical measurements (reading) of the oval shading threshold by the Random Manual Audit Team (RMAT) and the Vote Counting Machine (VCM)," it added.

On the other hand, the "After auditing seven audit found 100 percent matching

are the votes from Trece Martires City, 830 out of 830; Indang, 336 out of 336 and Amadeo, 247 out of 247.

The Poll Automation Law mandates the conduct of RMA, which is done by manually counting the votes on the machine-readable paper ballots to determine the accuracy of the election results.

Crispin Diego "Ping" Diaz Remulla won the special polls after receiving 98,474 votes against his three other rivals.

He was proclaimed the new representative of the 7th District of Cavite on Sunday, a day after the polls.

# EDITORYAL

## Long overdue modernization

PURSUING the protest action while defying the appeal of the President may indicate a different agenda that seeks to undermine the government.

The modernization program for public utility vehicles was initiated during the term of former transportation secretary Arthur Tugade with his oft-repeated objective of the government to make life comfortable for Filipinos.

When the pandemic struck in 2020, the first to take a hit were jeepney drivers as quarantine regulations forced them off the road.

The program was postponed repeatedly to allow the public transport sector to recover.

When normalcy returned, the government wanted the modernization plan resumed. The program was adjusted in that no phaseout would happen in the meantime but jeepney operators would have to join cooperatives that would facilitate the purchase of modern vehicles.

The government again relented as the Land Transportation Franchising and Regulatory Board moved the deadline for the cooperative scheme to the end of the year.

Despite an appeal from President Ferdinand "Bongbong" Marcos Jr. to hold off the protest, jeepney groups insisted on a one-week strike just for a show of strength.

Presidential Chief Legal Counsel Juan Ponce Enrile said jeepney groups are abusing the patience of the government and that they should not block the long overdue modernization program.

"They are abusing their right to assemble and seek redress of grievances. They are mandated to provide public service," Enrile said. "Let them hold their protest action but the government should cancel their franchises. No more, you can't engage in that trade," he added. "Government must stand up to protect the people, who will suffer from their strike. Can they be allowed to punish the public who have allowed them to engage in their business," said Enrile, who has the most extensive experience in government of all officials.

"Government should remove their licenses and make them find a job elsewhere," an incensed Enrile went.

President Marcos on Wednesday said a review of the program will be undertaken to allow adjustments and to move the 30 June deadline.

He explained that the PUV modernization program needs to be implemented "in a different way."

# SEC extends deadline for annual financial statements

QUEZON CITY -- The Securities and Exchange reports on or before their respective filing dates. Commission (SEC) has extended the deadline for the submission of annual financial statements (AFS) of corporations this year.

The petitioner's Compliance dated February 20, 2023, is

July 3, which will be subject to the prescribed penalties computed from the last day for AFS filing. The deadline extension does not apply to corporations whose fiscal year ends on a date other than Dec. 31, 2022, those whose securities are listed on the Philippine Stock Exchange (PSE), those whose securities are registered but not listed on the PSE, public companies and entities covered under Sec 17.2 of Republic Act 8799, or the Securities Regulation Code (SRC).

required to submit their annual reports online through The commission will accept late filings starting the SEC Electronic Filing and Submission Tool (eFAST). previously called the Online Submission Tool, at https:// cifss-ost.sec.gov.ph.

The commission recently issued SEC Memorandum Circular No. 1, Series of 2023 (SEC MC 1), which provides the extension of deadlines for the 2023 filing of annual financial statements (AFS).

The extension seeks to provide external auditors more time to complete their statutory audits of the financial statements of corporations.

Under the newly issued memorandum circular, all corporations, including branch offices, representative offices, regional headquarters and regional operating headquarters of foreign corporations whose fiscal years ended on Dec. 31, 2022 shall file their AFS based on the last digit of the SEC registration or license number, in accordance with the revised schedule:

1 and 2 : May 29 to 31; June 1 to 2

3 and 4 : June 5 to 9

- 5 and 6 : June 13 to 16
- 7 and 8 : June 19 to 23
- 9 and 0 : June 26 to 30

The SEC extension offices will also implement the coding schedule. Corporations may submit their

Corporations whose AFS are being audited by the Commission on Audit (COA) are likewise not covered by the deadline extension.

Such corporations shall provide an affidavit signed by the president and treasurer or chief finance officer attesting to the fact that the company timely provided COA with the financial statements and supporting documents and that the audit of the COA has just been concluded as well as a letter from the COA confirming the information on the affidavit are attached to their AFS.

Other provisions of SEC Memorandum Circular No. 9, Series of 2022, which provided the original schedule for AFS filing, remain in effect.

All stock and nonstock corporations are still

Submissions over the counter and through courier shall not be accepted.

Failure to follow the formal requirements prescribed under Revised SRC Rule 68 shall be considered a sufficient ground for the imposition of penalties by the SEC.

The acceptance and receipt by the commission of the financial statements shall be without prejudice to such penalties.

Moreover, the General Information Sheet (GIS) must be filed within 30 calendar days from the date of the actual annual stockholders' meeting for stock corporations, from the date of actual annual members meeting of nonstock corporations, and from the anniversary date of the issuance of the SEC license for foreign corporations.



# For nth time, frats urged to adopt strict anti-hazing policy

MANILA – The Philippine National Police (PNP) on Thursday called on fraternities operating in academic institutions to adopt a strict anti-hazing policy pursuant to Republic Act 8049 or the Anti-Hazing Law.

PNP public information office chief Col. Redrico Maranan made the call in the wake of the hazing death of John Matthew Salilig, a 24-year-old chemical engineering student from Adamson University.

Maranan said under the law, school officials should communicate with the families of the students and should also work with PNP.

This, as the police force

can only step in when there is violation of the law as such illegal activities often take place within school premises.

"Ang atin mensahe sa lahat ng fraternity na nandiyan sa loob ng eskuwelahan, ang pagsasagawa ng hazing ay isang labag sa batas ang penalty rito ay pagkakulong habambuhay. Huwag gawin yan sapagkat nakakamatay at nakakasira ng buhay ng tao at nakakasira ng pamilya (Our message to all the fraternities in school campuses, hazing is against the law and the penalty here is life imprisonment. Avoid it because it kills and destroys human life and family)," Maranan said in an interview with reporters.

MANILA – Speaker Ferdinand Martin G. Romualdez on Wednesday offered a PHP500,000 reward for anyone who can provide information that will lead to the arrest of those responsible for the death of John Matthew Salilig, who allegedly died of hazing.

In a statement, Romualdez said the reward is to encourage individuals to come forward and coordinate with the authorities "to help in the arrest and prosecution of the suspects, or those who have knowledge behind the death of Salilig."

He condemned the gruesome killing of the Adamson University chemical engineering student, stressing that "a loss of life is not acceptable in a civilized society like ours."

"Brothers do not kill brothers. Frat-related or not, any crime that results to death deserves utmost condemnation," Romualdez said.

He denounced the perpetrators as "wala silang

pagpapahalaga sa buhay" (they have no respect for life), as they should have taken Salilig to the hospital instead of dumping his body in an open field in Imus, Cavite.

"Kung ako na hindi kamag-anak ng biktima ay hindi matanggap ang ganitong karumaldumal na krimen (If I, who is not related to the victim, cannot accept this gruesome crime), how much more ang kanyang mga magulang at pamilya (his parents and family)," he lamented.
