DOH starts Cavite-wide orientation on BHWs' role under UHC

TANZA, Cavite - The Department of Health in Region IV-A has started its provincewide orientation of Barangay Health Workers (BHWs) in Cavite about primary health care at the community level and their responsibilities under the universal health care (UHC).

Themed "Sa UHC Walang Maiiwan, BHW ay Kailangan," the two-day capacity building seminar held at Tanza Oasis Hotel on August 29-30 delved not just on its specific role, but includes basic training on health care. "including the preventive and curative aspect," said Chief Local Health Support Division Dr. Noel G. Pasion.

BHWs. considered as "navigators" under the UHC should know where to

refer the patient which will help decongest government hospitals, especially the 2nd and 3rd level ones.

More than 500 Treceños availed the free healthcare services provided by the Provincial Health Office in cooperation with Trece Martires City Health Office during the medical and dental mission conducted in Brgy. Aguado on August 20, 2019. Seventy residents underwent tooth extraction performed by the dental team of PHO and TMCHO while the medical team of Gen. Emilio Aguinaldo Memorial Hospital checked the health status of more than 400 patients who were also given the prescribed vitamins and medicines. Multilab Diagnostic and Health Services also rendered free random blood sugar test. The mission was made possible thru the assistance of Inocencio Paramedic and Rescue Volunteers (IPARV), barangay health workers and nutrition scholars and the barangay officials of Aguado headed by ABC President Jaimer Sierra. Trece Martires City Mayor Gemma Lubigan and Vice Mayor Bobby Montehermoso with the Sangguniang Bayan members were present at the event and expressed their appreciation to the provincial government's effort in providing health assistance to Treceños.

projects are located in Davao, Central Visavas, Calabarzon, Central Luzon, and the National Capital Region (NCR). Earlier this year, DBP granted a P650million loan to the provincial government of Davao Oriental for various projects including the acquisition of heavy equipment for infrastructure projects and the establishment of potable water systems. It has also approved a P600-million loan to the city government of Tuguegarao for the repair of various roads in the city and construction of public market.

DBP also lent P64.4-billion to social infrastructure projects or those involving health care, education, housing, and solid waste management, Herbosa said. DBP funded the recently-inaugurated Parañaque Sewerage Treatment Plant (STP) of Maynilad Water Services, Inc. The new facility removes pollutants from wastewater currently collected from about 100,000 Maynilad customers in Parañaque City before its discharge to the Malabon Creek,

which eventually flows out to Manila Bay.

Herbosa said DBP also lent P50.9-billion to the agriculture sector for projects involving forestry, fishing, and wholesale and retail trade of agriculture products. "DBP also provided financing in the amount of P36.8-billion to strategic sectors and industries that adopt environment-friendly processes and technologies," he added.

DBP's funding assistance to the mSME sector, meanwhile, stood at P23-billion, with enterprises based in Davao, Northern Mindanao and Soccsksargen among the top recipients of the bank's development assistance. It recently funded the construction of a tunnel-ventilated poultry building of Amaris Farm in Camarines Norte to promote agribusiness and boost farm productivity in the province.

"Moving forward, DBP will continue to remain true to its developmental mandate by supporting key sectors of the economy," Herbosa said. "The bank will likewise intensify

its drive to promote financial inclusion especially in unbanked and underserved areas of the country in order to remain a relevant and responsive partner of the National Government in promoting inclusive growth particularly in the countryside."

DBP has recently launched the Lending Initiatives for Sanitation (LINIS) program aimed at assisting public and private entities including local government units and water districts in establishing waste water treatment facilities. It also supports the National Government's public utility vehicle modernization program through its Program Assistance to Support Alternative Driving Approaches (PASADA) financing program which offers reasonable terms to transport cooperatives looking to acquire brand new, low-emission, and fuel-efficient public utility vehicles. The bank has also opened the Contract to Sell Financing Facility aimed at assisting housing developers to expand their housing projects through DBP's purchase of receivables covered by a Contract to Sell. TRECE MARTIRES, Cavite – More than 90 members of the five pillars of justice system recently gathered for a dialogue consultation to assess some prevailing issues of the youth and address the local government unit's concerns in handling cases of Children In Conflict with Law (CICL).

Solving the LGBT public toilet problem

THE recent incident regarding a transgender woman who was barred from using a women's restroom in a shopping mall created issues that will not be resolved by the sweeping suggestion that separate toilets for individuals belonging to the Lesbian-Gay-Bisexual-Transgender (LGBT) community should be put up in public areas.

At this juncture, it must be stated that this essay is not intended to bash members of the LGBT. Its sole intention is to emphasize that some social problems cannot be solved overnight, even by legislation.

Putting up separate public toilets in public places is easier said than done. As every architect knows, it is more expensive to construct a toilet than to put up a room. It's the plumbing that makes it expensive. Every additional toilet will mean more additional water consumption. In turn, it means an increase in the water bill. Also, putting up an additional toilet requires additional space. From a mercantile perspective, an additional toilet translates to less space for commercial activity.

Putting up separate toilets for the LGBT community may not be a problem for large shopping malls and high-end hotels. They can afford the additional expense, or they can apportion some of their many existing toilets for LGBT use. Besides, they will just pass on the additional expense to their tenants.

Small restaurants and budget-class eateries may have a problem. The expense for constructing and maintaining an additional toilet will add to the overhead expenses, and will reduce whatever limited space they have for their customers.

In the long run, the smaller dining establishments may close shop and add more people to the unemployment line. That also runs afoul of the country's policy of encouraging small- and medium-scale enterprises.

So far, there are no additional toilets for the LGBT community in the shopping malls and smaller restaurants and cafes. What happens now?

It's easy to say that a transgender woman should be allowed to use the women's rest room.

A problem arises if there are women inside the women's rest room who are not comfortable with an ex-male in their midst. What if they suspect that the transgender woman is not really a transgender?

Putting up a separate toilet facility for the LGBT community is the solution — or isn't it?

What if a member of the LGBT community is not comfortable being in the same LGBT toilet with another member of the LGBT community? For instance, what will happen when a transgender woman protests the presence of a lesbian inside the LGBT toilet being used by the transgender woman?

In theory, a bisexual is entitled to use an LGBT toilet. From a practical perspective, however, it may not seem to be that way. Since a bisexual man can dress up in male attire and a bisexual woman can dress up in female attire, it is easy for one to claim to be a bisexual when he or she is not, and then demand access to the LGBT toilet. That will create a problem.

At the end of the day, Congress should not rush legislation requiring a separate toilet facility for the LGBT community. All potential problems must be considered first.

In the meantime, the practical solution is for the management of the shopping mall, building, commercial establishment or restaurant concerned to assign a security officer or employee to take care of complaints relating to untoward incidents involving any LGBT toilet user. That security officer or employee should be ready to provide protection to any LGBT toilet user who faces possible discrimination or harassment. In extreme cases, the management must seek assistance from barangay or police authorities to prevent discrimination against LGBT toilet users.

Setyembre 16, 1991. Kahit aktibo siya sa mga debate sa eskwela tungkol sa isyu, hindi niya alam kung kailan pagbobotohan ang ekstensyon ng US-RP Military Bases Agreement. Tutol siya, salamat sa mga babasahing uwi ng ate niya, bukod pa sa natural yatang pagkampi sa mga rebelde. Hanggang sa araw na ito, may klase pero parang wala. Lahat ng guro, nakatutok sa telebisyon sa departamento ng agham panlipunan. Dahil silang mga titser - sa agham panlipunan, Filipino, Ingles at iba pang katulad na aralin - ang isponsor ng mga debate, nagpanggap silang nyutral. Nagpabisto na lang sila nang ibinasura ang tratado: palakpakan sa departamento, hiyawan, dinig sa buong paaralan.

Nangalay ang leeg niya kakatingin sa langit, kakaabang sa mga helikopter noong Edsa 1. Nakabisado niya ang mga kandidatong senador sa eleksyong 1987 – bukod sa Partido ng Bayan, na inisip niyang panggulo. Napanood niya ang galit na talumpati ni Cory Aquino matapos ang isang kudeta: "Babanggitin ko pa ba iyang Doy [Laurel] na iyan? O pipitikin na lang nating parang langaw?" Pero ibang sigla ang talakayan tungkol sa base-militar. Sa hayskul, maraming umpukan ng estudyante na nag-eensayo para sa debate sa klase. Kahit ang Mel & Jay, inere ang debate, kung saan tampok si Nat Santiago, mahusay na lider-estudyante at anti-base. Laging laman ng radyo't telebisyon ang isyu.

September 16 Movement. Ito ang ipinangalan sa alyansa noong 1998-1999 laban sa Visiting Forces Agreement na gustong iratsada ni Erap Estrada, pangulong dating senador na kontra-base. Sabi nga nito ilang panahon pagkatapos: "Weather-weather lang iyan." Bukod sa nangangahulugan ng pagbabalik ng basemilitar ng US, mas masahol ang VFA; bukas ang buong bansa sa tropa at armas-militar ng US. Pwede pang magpasok ng armasnuklevar, labag sa Konstitusvon. Pero ilan lang sa mga senador na tutol sa naunang tratado ang lumaban. Nasa Senado siya nang aprubahan ang VFA: Mayo 1999, kaya hindi kasing-laki ng dapat ang mobilisasyon mula sa mga paaralan.

Naglulunsad sila ng gabing pangkultura sa kampus, paghahanda sa isang mobilisasyon para sa P125 across-the-board na dagdagsahod sa buong bansa. Nakatanggap sila ng mensaheng text: Nagsimula na raw ang World War III, pagkatapos ay ikinwento ang pagsalpok ng mga eroplano sa World Trade Center sa New York at iba pang detalye. May ilang umalis para manood ng telebisyon; ang kalakhan, hindi makapaniwala o hindi alam ang halaga ng nangyari. Pero kakatwa

ang perspektiba ng mensaheng text. Tama ba ang salitang "propetiko"? Itinuring nga naman ng rehimeng W. Bush ang tinawag nang "9/11" bilang deklarasyon ng digma, probokasyon ng WW III.

Hindi nga magtatagal, protesta na sa gera sa Afghanistan ang ilulunsad at sasamahan niya. Galing Saudi Arabia ang mga terorista sa 9/11, pero hindi magera ng US ang naturang bansa. Si Osama bin Laden ang itinuturong utak at tagapondo, pero kailangan bang bombahin at sakupin ang buong Afghanistan? Pagkatapos, Iraq naman. Mas dumami na ang nagpoprotesta. May pagkilos sa Quirino Grandstand, Ateneo de Manila University, at Makati kasama ang Simbahang Katoliko. Nasubaybayan ang paglipat-lipat ng US sa mahigit limang palusot para sa gera: mula sa umano'y weapons of mass destruction na nasa kamay ni Saddam Hussein hanggang sa paghahatid ng demokrasya.

TO REMEMBER

Maganda ang obserbasyon ng isang Anthony Paul Smith hinggil sa paggunita sa ika-10 taon ng 9/11 sa US: "Sumisigaw ang midya sa pagmumukha nating lahat: GUNITAIN MO!" Aniya, "ang utos ay gunitain natin sa paraang gusto nila" - sa partikular, "ang ating takot sa araw na iyun, ang pagkagulantang natin, ang nawala sa atin." Simple nga naman ang alalahanin ang isang pangyayaring dahil sa midya at makabagong teknolohiya ay sabay-sabay na naranasan ng marami, kung hindi man ng nakakarami. Pero wala na sa partikular na karanasan ng bawat isa ang katotohanan ng buo. At ang panawagang ito ng paggunita ay tulak para sa mas malaking paglimot at

Hindi masasaklaw ng personal na paggunita ang kabuuang pagtatasa sa "gera kontra-terorismo" na inilunsad ng US, bagay na sinikap gawin ng ekonomistang si Joseph Stiglitz. Mas mahal sa gera sa Vietnam at Korea, at maging sa Unang Digmaang Pandaigdig. Ang tanging mas mahal ay ang Ikalawang Digmaang Pandaigdig. Lumobo ang utang ng gobyerno US dahil sa gera, na hinuthot naman ng mga monopolyo-kapitalista at pinagbabayaran ngayon ng mga mamamayang Amerikano. Mahigit 7,000 sundalong Kano na ang namamatay sa Iraq at Afghanistan, mahigit doble ng 3,000 namatay noong 9/11. Maraming ari-arian ang winasak at karapatang tinapakan.

MAHABANG PAHABOL

Kahit noong naganap ang 9/11, nabalita na ang mga tumalon sa World Trade Center, pero hindi pa ako nakaengkwentro ng masinsing pagsasalaysay nito. Heto ang sa progresibong mamamahayag na si Chris Hedges, bahagi ng paggunita sa 9/11:

"Maraming tao, malamang lampas 200, ang tumulak lampas sa usok at init para tumalon sa kanilang kamatayan mula sa mga bintanang nabasag o winasak nila. May gumawa nito nang mag-isa, may gumawa nang magkasama. Pero parang pumila sila, isang katawang tumatapon pabagsak ang susundan ng isa pa. Mga huling hakbangin ng indibidwalidad. Bumagsak sila nang mga 10 segundo, marami ang kumakampay-kampay o katulad ng paggalaw ng mga manlalangoy, umabot sa 150 milya kada oras. Nawasak ang kanilang mga damit at, sa ilang kaso, ang gawa-gawa nilang parachute mula sa mga dekorasyon o mantel. Humataw sila sa kalsada nang may nakakabagabag, nakakahilakbot na umpog. Bog. Bog. Bog. Ang mga nakasaksi, partikular na nagulantang nang husto sa tunog na likha ng mga katawan sa pagtama.

Masyadong nakakahilakbot ang mga larawan ng mga "jumper" para sa mga network sa telebisyon. Kahit bago gumuho ang mga tore, sinensura sa mga live na balita ang mga nahuhulog na kalalakihan at kababaihan. Lumabas ang ilang larawan sa sumunod na araw sa mga dyaryo, kasama na ang The New York Times, at pagkatapos ay nawala. Nabura ang maramihang pagpapatiwakal, isa sa pinaesensyal at pinakamahalagang elemento sa kwento ng 9/11. Nananatili itong burado sa kamalayan ng publiko.

May sinasabing kung anong malalim, nakakabagabag, ang kapalaran ng mga "jumper" tungkol sa ating kapalaran, pagiging maliit sa uniberso at kahinaan kaya kinailangan itong ipagbawal. Ipinapakita ng mga "jumper" na may hangganan ang pagdurusa na humahatak ng mulat na pagyakap sa kamatayan. Ipinaalala ng mga "jumper" sa atin na darating, sa ating lahat, ang mga yugto ng katapusan kung kailan ang tanging pagpipilian, sa pinakamainam, ay kung paano natin pipiliing mamatay, hindi kung paano tayo mabubuhay. At pwede tayong mamatay bago tayo pisikal na

Pero hiniling ng pagkagulantang ng 9/11 ang mga imahen at istorya ng katatagan, kaligtasan, kabayanihan, kagitingan, pagsasakripisyo ng sarili at pagiging bukas-palad, hindi kolektibong pagpapatiwakal sa harap ng napakalakas na kawalang-pag-asa at pighati."

Woodcarving, woodlots, and women: Sustaining forests and families

When one travels to the tourist town of Banaue in Ifugao, the rice terraces are not the only ones you can't help notice.

Small shops along the road stand side by side each other displaying a variety of woodcarvings from the famed "bululs" (rice gods) to home decors, tissue holders, and souvenirs.

Big hunter statues and furniture sets are often the centerpieces until recently, small items carved to the minutest detail of a native house, good luck charm, and novelty items became popular.

Ifugao woodcarving

Woodcarving in the province of Ifugao can be traced back to the pre-Spanish period. The practice of the craft can also be associated to the existence evident in the "bululs" carved as protection and an important part of the rituals in the rice cycle of the Ifugao people.

After the Second World War, there was a boom in the tourism industry in the town of Banaue. Along with it, woodcarving became an additional income generating activity for most families.

"Economically, Ifugaos have limited sources of income. Since rice production here is only once a year, families cannot be sustained by just relying on rice production, " said Banaue Municipal Assessor Peter Udan.

Women Woodcarvers

Women woodcarving industry are usually in charge of the finishing touches of the wood products but not

until recently when they started to get involved in carving their own products.

Trinkets, key chains, and earrings are now some of the recent souvenirs that woodcarvers from Banaue produce.

These items maybe smaller than your average woodworks but the details put in them take as much hard work and patience.

"What's unique to women woodcarvers is their patience to carve small items as compared to the men who prefer to carve the larger pieces" said Maribel Dango, President of the Banaue Women Wood Carvers Organization.

The Banaue Women Sculptor Organization started in 2016 with a woodcarving exhibit organized by the local government unit.

With now 16 members of the old-aged rice terraces as from barangays Bocos and Viewpoint, the organization continues to showcase their skills and works during festivals like the Imbayah and the Gotad ad Ifugao.

> "The reason organized an exhibit for them was to adjust the price from P0.10 per item to at least P0.35 ," said Udan.

> Unlike commercialized products produced in bulks using machines, the items carved by the women woodcarvers are handmade. Sometimes, these items are made while the women are taking care of the children and household chores.

Sustaining the family

Income sources for the typical Ifugao family is usually limited to the father going out to the fields and bringing in cash.

However, with women now active in selling wood carved items, there is supplemental revenue for the family.

"Woodcarving helps a lot especially when it comes to our finances. When the family falls short in money, we can get extra income here," said Darcy Banghuyao, a member of the Banaue Women Sculptor Organization.

Although the women woodcarvers sell smaller pieces, Udan said they can earn money equal to the value of the larger

Preserving the natural forests

Usually, when one talks about the woodcarving industry, one cannot avoid to tackle issues of deforestation especially in areas with large forest covers.

In numerous studies. the growth of the woodcarving province industry in the

is associated as one of the contributing factors of declining of forests.

The government also memorandums and issued department orders to ban the cutting of trees that destroy forest areas.

Contrary to impression that woodcarving is a dangerous industry particularly for Ifugao forests, explained that the Ifugaos, long before the laws and regulations were put in place, knew how to take care of their woodlots.

"Woodcarving is an industry that knows how to preserve its own natural forest," he said.

Before woodcarving became a source of income, most farming families clear entire mountains to plant food crops as an alternative livelihood to rice production.

The development of the woodcarving in the municipality helped stop this slash-and-burn agriculture.

"Families will not clear mountains to plant sweet potatoes anymore because by carving two to five trees in a certain period of time, they can already have supply of their basic needs while having the forest preserved,"

Udan explained.

He said with the women woodcarvers, the raw resources are maximized into coming up with a marketable products from the trunk, branches up until to the pine needles.

Scrap wood from making the large items can also be turned into the smaller souvenir pieces.

Expanding the market

Through exhibits in different events and festivals, the Banaue Women Sculptors Organization is now able to get orders inside and outside the country.

Udan said he sees a strong potential in international market for their products.

"It's good that the administration Duterte encouraging enterpreneurship,"

Through the right kind of enterpreneurship and strong government support, Udan envisions the wood carvers as owners of an organization that helps give an adequate and reliable source of income to secure a better life for their families.(JDP/JJPM-PIA CAR)







President Duterte to Chinese counterpart: Let's reaffirm value of our relations

PASIG CITY -- The Development Academy of the Philippines (DAP), through its Center for Governance (CFG), conducted the fifth run of the course on advanced monitoring and evaluation (M&E) last July 22-26 at the DAP Building in Pasig City for some 38 participants representing various national government government-owned agencies, controlled corporations, local government units, state universities and colleges, and the private sector.

The three-day course intends to build and enhance the participants' skills and understanding of M&E as well as provide them with up-to-date and deeper knowledge of M&E that will enable them to evaluate their agencies' programs or projects using statistical analysis and other methods.

The resource persons for

the course include DAP Director Gilbert Lumantao, Tanya Hamada of the Institute for Leadership, Empowerment, and Democracy, Francis Joseph Dee and Dr. Maria Ela Atienza from the University of the PhilipinesDiliman-Department of Political Science; Dr.MerlynePaunlagui from the University of the Philippines Los Baños – College of Public Affairs and Development. Likewise, Hamada and Paunlagui led workshops on the creation of each group's Theory of Change templates and Impact Evaluation Terms of Reference outputs, respectively.

DBP 1st half net income rises 12.3% to P3.1-B

MAKATI CITY -- State-owned to P667.91-billion from the Development Bank of the Philippines (DBP) grew its net income to P3.1- billion in the first half of 2019, representing an increase of 12.32% from the P2.76-billion reported during the same period last year.

DBP president and chief executive officer Emmanuel G. position of the bank puts it in a prime position to support the various growth initiatives of the Duterte administration.

"The remarkable financial performance of DBP has fortified its stance and resources to fund the priority development programs of the National Government," Herbosa said.

The eighth largest bank in the country in terms of assets, DBP lends to strategic growth sectors such as infrastructure logistics; micro, small medium enterprises (mSMEs); social services and community development; and the environment.

Herbosa reported that DBP's gross loan portfolio increased by 19.79% to P368.33billion from the P307.47-billion posted in the previous year.

"Total assets grew

P617.87-billion last year and net worth increased by 16.33% to P56.78-billion," Herbosa added. "Our capital adequacy ratio stood at 14.03%, which is higher than the industry average of 12.12%"

DBP also grew its deposit levels to P464.83-billion in the first six months from the Herbosa said the improved fiscal P431.65-billion reported in the same period last year, driven by the aggressive marketing and financial inclusion initiatives undertaken through its expanded branch network. DBP has 137 branches that include 10 branchlite units that cater to underserved and underbanked areas in the country.

> Lending to strategic sectors

> Herbosa also underscored DBP's continued support to strategic sectors of the economy such as the infrastructure and logistics sector, which received nearly P143-billion in funding assistance. of the funding went to projects in key industries like energy, water resources, manufacturing, transportation, construction, and manufacturing," he said. He added that most of these

Palace reports President Duterte's fruitful China visit West Philippine Sea, including

MANILA-- President Rodrigo Roa Duterte had a productive five-day official visit to China, reaffirming the country's longstanding ties with the Asian economic giant during his meeting with President Xi Jinping and Premier Li Keqiang in Beijing, a Palace statement said Sunday.

The President returned to Manila on Sunday morning after his official visit to China. It was

his fifth trip to the Asian neighbor since he became President.

"The two leaders reaffirmed the long-standing friendship between the Philippines and China and renewed their commitment to further enhance our countries' Comprehensive Cooperation," Strategic statement said.

"Presidents Duterte and Xi had candid and open exchange of views on the South China Sea/

the Arbitral Award which the Philippines won in 2016," it added.

Acknowledging importance of a Code of Conduct (COC) in the South China Sea to regional peace and stability, the two leaders have expressed determination to fast-track negotiations for the conclusion of a binding COC.
